# YOUR HELP CONTINUES TO BRING JOY TO AREA COMMUNITIES

Deer season in Wisconsin is just around the corner so it's time to sight in your rifles and get your deer

camp ready for the big week. Hunting is a sacred tradition in Wisconsin, but don't forget to practice good hunting safety and stay alert for hidden dangers. Also, never place your tree stand near a power line and do not shoot towards power lines, utility poles, transformers, or substations. Stay safe out there!

At their September meeting, the Board of Directors approved the retirement of capital credits in the amount of \$300,000. Capital credits are the margins distributed to the members of the cooperative based on their energy purchases from the cooperative in previous years. The capital credit retirement this year will be made by applying 70% of the retirement to the oldest year on record and 30% of the retirement to more recent years. This method provides a fair retirement rotation and allows us to clear older years off the books. See page 16 for more information. As the cooperative is financially able, it is a privilege to return a portion of your investment in the cooperative to you.

When we retire capital credits, a small number of former members cannot be located and their retired capital credit amount is unclaimed. Per Wisconsin statute, we are able to use our unclaimed capital credits for charitable giving and scholarships. We donate our unclaimed dollars to Federated Youth Foundation in accordance with the provisions of our bylaws, and those dollars are available to the cooperative to help our local communities and students achieve their goals. It has been my pleasure to serve on the Board of Directors of the Federated Youth Foundation for several years and to see the tremendous impact this program has on rural Wisconsin.

One of the most beneficial and rewarding community service programs we participate in is the Toys for Tots program. Your generous donation of toys has put smiles on the faces of thousands of children since the program

# **BOARD MEETING SUMMARY**

The August regular meeting of the Board of Directors of Central Wisconsin Electric Cooperative was held in-person on August 25, 2022 at 7:59 a.m. The following is a summary of the meeting activities. The agenda, minutes of the July 28, 2022 meeting, new and terminated memberships, monthly safety and compliance report, and estate capital credit retirements were approved.

#### Action Items

- Monthly Financial Statements and Reports were approved. Finance Committee reviewed checks written and the board and CEO expenses.
- b. The board approved revisions to Board Policy 402-Financial Goals and Capital Credits and Board Policy 202-Director Fees and Expenses as presented by the Governance Committee.
- c. The Board reviewed Board Policy 408 Retirements of Capital Credits for Deceased Patrons with Exhibits and Documents and made no modifications.
- d. Mr. Kevin Kurtzweil and Mr. Dennis Magee gave an informational presentation to the board on the training we provide to area First Responders.
- e. Ms. Brenda Mazemke gave a presentation to the board on the upcoming 2022 Member Satisfaction Survey.

f. The board reviewed a modified work schedule pilot project as presented by the management team.

Operations and Engineering – Mr. Kurtzweil reported crews are working on the Robin Road overhead line project. The Alliant Energy tie was used to back feed Wittenberg feeder 3 a few weeks ago and worked very well.

Accounting and Finance – Ms. Lila Shower gave an update on the corrected amount of the refund we will get from Wisconsin Disaster Fund from the June 16th storm damage in Shawano County.

Member Services – Ms. Mazemke reported we have received 67 entries for the calendar photo contest. Mr. John LaValley completed key account and business account visits in Tigerton. Mr. LaValley and Mr. Bert Lehman recently attended the Member Services Association Annual Meeting and the Electric Communicators Workshop in Wisconsin Dells. Mr. Lehman will be attending Toys-For-Tots training in Virginia next month.

Administrative Services – Ms. Patoka reported the details are finalized for the Badger Power Cooperative Annual Meeting next week Tuesday, August 30, 2022 in Wisconsin Dells. The cooperative attorney is assisting us in updating employee policies.

President and CEO – Mike Wade, CEO, reported on his submitted report.

# CO-OP RETIRES \$300,000 IN CAPITAL CREDITS

# WHAT ARE CAPITAL CREDITS?

One of the benefits of being a member of Central Wisconsin Electric Cooperative (CWEC) is that members are eligible to receive capital credits, which represents your ownership in CWEC.

Unlike investor-owned utilities that maximize profits to pay dividends to shareholders, CWEC, which is a not-for-profit electric cooperative, provides our members with "at cost" electric service. We do not exist to earn a profit.

When each year's finances are audited and closed out, the remaining profit or margins are allocated to the members based on the amount each member paid for electricity during the year in the form of capital credits. These capital credits are used by the co-op to help build and maintain the CWEC electric system. When the co-op's finances permit, the Board of Directors approves a portion of the allocated capital credits to be retired, and paid back to you—the members.

# **ALLOCATION OF RETIRED CAPITAL CREDITS**

This year, the board of directors approved the retirement of \$300,000 in capital credits. That amount was divided as follows: 70% of the \$300,000 went to members who had capital credits from 1993 and prior years; 30% went to members with capital credits from 1994 through 2017. All members who have been on CWEC electric lines for six years or longer received retired capital credits.

Active members whose retired capital credits were less than \$100 received a credit on their September electric bill, which was mailed to members in October. Checks were mailed in October to active members whose retired capital credits amounted to more than \$100. Checks, with a minimum of \$10, were also mailed to all offline members who received retired capital credits.

# NATURAL GAS PRICE IMPACTS COST OF ELECTRICITY

As you have noticed with your last two monthly electric bills, the cost of electricity is increasing. This is due to an increase in the power cost adjustment (PCA), which is a variable cost that changes each month based on how much it costs to generate power we purchase from Alliant Energy.

Prior to the last three months, CWEC had been successful for 20 straight months in keeping the PCA to a zero or a negative number for our members.

The main driver for the higher energy costs has been the sharp cost increase for natural gas. This is mainly due to lower supply and higher demand.

Another driver for the increase in energy

prices are problems Alliant is having in receiving regular shipments of coal due to railway issues. Railroads are struggling to recover from COVID and are still seeing a shortage of workers. If a coal plant does not have sufficient coal to operate, it goes into coal conservation mode and cannot operate as it normally would. Coal prices have increased slightly, but the bigger driver of higher coal costs is the higher transportation cost.

With the spike in fuel costs, the PCA is now a charge that is much higher than we've seen in recent years. This trend is likely to continue.
