The July regular meeting of the Board of Directors of Central Wisconsin Electric Cooperative was held in-person on July 29, 2021 at 7:59 a.m. The following is a summary of the meeting activities. The agenda, minutes of the June 24, 2021 and July 15, 2021 meetings, new and terminated memberships, monthly safety and compliance report, and estate capital credit retirements were approved.

Action Items

a. Monthly Financial Statements and Reports were approved. Finance Committee reviewed checks written and the board and CEO expenses.

- b. The board approved the proposed changes to the Membership Agreement, Policy 408-Retirement of Capital Credits for Deceased Patrons, and Chapter 4.0 Billings, Payment and Special Charges as recommended by the Governance Committee. The committee is reviewing Policy 106-Director Education and will have a recommendation for the board at the August meeting.
- c. The board reviewed Board Policy 107-Committee Assignments with no suggested changes.
- d. Ms. Shower presented the 10-year financial forecast to the board.
- e. Ms. Mazemke gave an informational presentation to the board on the new Microsoft SharePoint intranet used by the employees.
- f. The board approved the recommended changes and additions presented by Ms. Mazemke regarding CWEC's Energy Conservation Rewards Program.

Operations and Engineering – Mr. Kurtzweil's report was reviewed by Mr. Wade.

Accounting and Finance – Financial reports were reviewed. Ms. Shower reported the AMI system upgrade committee is in the final stages of their meetings with vendors and will be selecting a new system soon.

Member Services – Ms. Mazemke's report was reviewed by Mr. Wade.

President and CEO – Mike Wade, CEO, reported on his submitted report.

COBANK SHARING SUCCESS GRANT PROGRAM RECIPIENTS ANNOUNCED

One of the most unique programs Central Wisconsin Electric Cooperative (CWEC) participates in is the CoBank Sharing Success Grant Program. The annual Sharing Success grant opportunity is made possible by CWEC's governing board of trustees, in partnership with CoBank, a national nonprofit cooperative bank owned by the rural American cooperatives it services, including CWEC.

CoBank established a \$3 million fund to match charitable contributions made by its cooperative members. The matching grant program is designed to celebrate the vital role that cooperatives play in individual communities across the country. CoBank states that partnering with their customers to support worthy causes is a great way for them to make a positive difference and fulfill their mission of service to rural America.

As a participating member of the CoBank "Sharing Success" charitable contribution program, CWEC makes up to three donations totaling \$1,000 each year to qualifying 501(c)3 organizations located within the communities that we serve and CoBank matches our donation to these organizations, totaling \$2,000 per organization.

CWEC's CoBank "Sharing Success" recipients for 2021 are: Marion Area Fire Department, Ogdensburg/St. Lawrence Fire Department, and Rural Health Initiative.

"We appreciate the generous donations," said Joe Stuhr, fire chief for the Marion Area Fire Department. "Thank you for having this awesome program. We will use it to purchase much needed tools."

Scott Miller, fire chief for Ogdensburg/St. Lawrence Fire Department, said, "Thank you for the donations. We will be putting it towards new hand-held radios and pagers."

"This grant funding is very important because we know that farmers are self-employed, have high health insurance costs and barriers to care, and that time away from the farm is difficult," said Rhonda Strebel, executive director of Rural Health Initiative. "Often healthcare and prevention is delayed. By bringing services to the farm we are keeping our farm workers healthy and safe."




